Eligibility Criteria

10 + 2 of any stream

To attain a **CMA**[®] certificate, the student must obtain a graduate degree and 2 years of work experience within 7 years of passing **CMA**[®] exams.

Eligibility Requirements :

To pursue the **CMA**, candidates must meet the following requirements:

- **Educational** : A **bachelor's degree** or equivalent from an accredited institution.
- **Work Experience** : **Two years of professional experience** in management accounting or financial management (can be completed before or after passing the exams).
- **IMA Membership** : Candidates must be a member of the **Institute of Management Accountants (IMA)** to sit for the exam.
